PUBLIC COMMENT

Public comment is the opportunity for members of the public to participate in meetings by addressing the Oak Park Municipal Advisory Council in connection with one or more agenda or non-agenda items. Public comments by a member of the public at a single meeting are limited to a cumulative total of five minutes at such meeting unless the time allotment is increased or decreased by the Chair depending on the number of speakers. The public comment period during the opening part of the meeting to address nonagenda items is limited to 30 minutes total for all speakers; this 30-minute limit does not apply to items on the agenda.

To maintain a public meeting environment conductive and welcoming to receiving public comments from all members of the public, the audience is discouraged from engaging in displays of support or opposition to staff reports or public comments, including clapping, yelling, booing, hissing or cheering, that may create a disruptive environment for members of the public wishing to participate. Any person who disrupts or impedes the orderly conduct of a meeting will be instructed to cease the disruptive conduct. Failure to do so may result in that person being removed from the meeting.

Members of the public who would like to augment their comments with visual or audio

presentations must submit their materials to the <u>supervisorgorell@ventura.org</u> for review at least 48 hours before the meeting. The review will be conducted to determine only whether the materials are on matters within the jurisdiction of the Municipal Advisory Council, would be disruptive of the meeting, or would foster illegality, such as identity theft. If it is determined that materials are about matters not within the Municipal Advisory Council's jurisdiction, or would be disruptive of the meeting, or would foster illegality, use of County-provided equipment will not be allowed.

If you wish to make a comment on a specific agenda item by email or mail, please submit your comment by 12:00 p.m. on the day prior to the meeting. Indicate in the Subject Line the Agenda item number (e.g., Item No. 9) on which you are commenting. Your email or written comment will be distributed to the Municipal Advisory Council and placed into the item's record for the minutes of the meeting. Public Comments submitted in writing are public records and subject to disclosure. An unredacted version is made available when records are requested by a Public Records Act request. - 11. Ventura County Fire Department Report
- This month, Ventura County experienced its first large fire of the year. The Mountain Fire burned more than 20,000 acres, destroyed nearly 200 homes in Camarillo and forced hundreds of residents to evacuate. The Ventura County Fire Department was supported by numerous agencies from across the state in responding to the fire. Those efforts are still underway at the time of this report. We are grateful for their assistance.
- A Local Assistance Center was being set up to guide residents and businesses affected by the fire through the recovery process and share information about assistance that might be available. Additional information will be available at vcrecovers.com.
- Once conditions enabled property owners to return to their properties, eight Community Patrols were established to assist in sorting through the remains of burned homes for items that might have survived. Those firefighters wore

personal protective equipment so they could work safely in the ash and debris, which also allowed the property owners to stay safe.

• Additional Santa Ana wind events are bound to happen. Everyone should remain vigilant about avoiding activities that could start a fire, such as a hot muffler against tall weeds, a dragging tow chain, a tossed cigarette or an outdoor fire pit.

17. Oak Park Landscape Request for Proposal Update and Recommendations

The County's Landscaper (GSA Supervisor) has offered the following feedback regarding cost savings measures for landscaping, specifically for Oak Park:

- Service could be schedule weekly during the summer and every other week during the winter, the change over would be in approximately April and October.
- An initial investment could be made to change some areas to hard-scape; follow up service would be minimal and water use would drop.
- There is a criteria for fertilization aeration dethatching of the lawn; this could be eliminated but residents will see a difference in the look of the lawn.
- All plants are marked up from what the landscaper pays. The elimination of annual plantings and conversion to perennials would be a one-time cost but a decrease in product and labor over time.
- Historically all trees were trimmed once every 3-years. This could be extended. Whatever criteria is desired, needs to be specified in the RFP scope.
- Expectations; eliminating terminology as "garden like" in the scope.
