PUBLIC COMMENT: Public comment is the opportunity for members of the public to participate in meetings by addressing the Oak Park Municipal Advisory Council in connection with one or more agenda or non-agenda items. Public comments by a member of the public at a single meeting are limited to a cumulative total of five minutes at such meeting unless the time allotment is increased or decreased by the Chair depending on the number of speakers. The public comment period during the opening part of the meeting to address non-agenda items is limited to 30 minutes total for all speakers; this 30-minute limit does not apply to items on the agenda.

To maintain a public meeting environment conductive and welcoming to receiving public comments from all members of the public, the audience is discouraged from engaging in displays of support or opposition to staff reports or public comments, including clapping, yelling, booing, hissing or cheering, that may create a disruptive environment for members of the public wishing to participate. Any person who disrupts or impedes the orderly conduct of a meeting will be instructed to cease the disruptive conduct. Failure to do so may result in that person being removed from the meeting.

Members of the public who would like to augment their comments with visual or audio presentations must submit their materials to the supervisorgorell@ventura.org for review at least 48 hours before the meeting. The review will be conducted to determine only whether the materials are on matters within the jurisdiction of the Municipal Advisory Council, would be disruptive of the meeting, or would foster illegality, such as identity theft. If it is determined that materials are about matters not within the Municipal Advisory Council's jurisdiction, or would be disruptive of the meeting, or would foster illegality, use of County-provided equipment will not be allowed.

Email or Mail Public Comment in Advance of the Meeting: If you wish to make a comment on a specific agenda item by email or mail, please submit your comment by 12:00 p.m. on the day prior to the meeting. Indicate in the Subject Line the Agenda item number (e.g., Item No. 9) on which you are commenting. Your email or written comment will be distributed to the Municipal Advisory Council and placed into the item's record for the minutes of the meeting. Public Comments submitted in writing are public records and subject to disclosure. An unredacted version is made available when records are

requested by a Public Records Act request. Please do not submit personal contact information you do not want to be made public. - 4. Approve Minutes of the June 26, 2025 Oak Park MAC Meeting J.L Diaz motion to approve, Brianna Adams 2nd Motion, All were in favor except Jane Nye abstains as she was absent for the June 26, 2025 MAC meeting.

7. Public Comments

- Ben Caldwell Requesting crosswalk on Los Arcos near entrance to Valley View Park. He's also concerned about speeding. He feels like the CHP and Sheriff's Office isn't responsive. Concerned about public safety.
- or Dina? Derington I have both of them down and Dina sent me a DM after the meeting – Very concerned about the Oak Park Shopping Center. She feels like it's in disarray. She feels like there needs to be more to bring it up to compliance.
- Brian Mattson

 34-year resident very concerned about the poor quality of landscaping services being provided over the past few months.. He feels like things are not being attended to and he's upset about the lack of response from Mariposa Landscapes Inc. to correct their problems. He also brought up concerns about the stoplight at Kanan Road and Golden Eagle Dr. He feels like Public Works keeps providing a different response for what is being done to address the on-going signal timing issue. Other specific areas of concern include inoperable irrigation sprinklers at the corner of Kanan and Golden Eagle, weeds throughout the community and excessive amounts of fallen pine needles on many of the sidewalks. He expressed interest in joining the Oak Park MAC Landscape Committee. Jane Nye commented that the landscape conditions are the worst she has ever seen as a long-time resident. Brianna Adams also commented that she runs through the neighborhood regularly and also is very concerned about the poor landscape condition and someone slipping or getting hurt. Brian Trushinski commented that he believes there should be one dedicated person on Mariposa's team that addresses these issues on a weekly basis rather than on a 4-week cycle as is currently happening.

- Janna Orkney She feels that landscape is also in poor condition. She's concerned about the condition of Lindero Canyon Rd. & Kanan Rd. She heard the irrigation was broken and wants more information. She also wants to volunteer on the landscape committee. She also wants a 25 mile per hour speed limit sign posted prior to school traffic. She wants this on Conifer Street between Satinwood and Kanan. She said there is a stop sign past this area that isn't helpful for the school traffic.
- Steven Kozel He requested that Ventura County Public Works Agency's public call logs (online service tickets) are being reviewed by County staff. He doesn't feel like reports of concerns to Public Works are being taken seriously. He believes that the landscape east of Hollytree to the County line is looking worse with pine needles. He feels this is a public and fire safety hazard. He feels like we need to be proactive because some people are not fire hardening their homes. He believes the Medea Creek Management Plan is excellent and he thinks it is important to get stakeholders together. He said it needs to be done based on science. For example, he said remove palm trees but leave the oak trees. Oak trees are excellent for capturing and defusing fire embers. They are nature's fire fighters. He also requested that the Oak Park Community Garden be recognized at the next MAC meeting. He said they are doing a great job with the school field trips and community education. Brianna Adams also agreed and appreciates the positive impact the garden is making on local kids.
- Debbie Sharpton She loves the Oak Park community. She was reading in the LA Times and there was a story about a 747-evacuation analysis, and she saw some cities have done like Malibu/Agoura are working on it. She wants to know if there will be one for Oak Park. She wants to see the analysis looking at disaster evacuation routes as required by State law. She also shared thoughts on streams. She shared that streams are important for the local habitat and she wants to work together on caring for Medea Creek. She wants stakeholders to come together who have interest to talk about and protect it. She also wanted to encourage community members to attend

Rancho Simi Recreation and Parks District's Board meeting on August 6 at 6:30 pm at Oak Park High in room G-9. Brianna Adams made a comment that things need to be explained on evacuations. She appreciates the work in law enforcement being on standby to direct traffic and also mentioned that the schools are now conducting wildfire evacuation drills. She believes the community should be informed on actions being taken. Brian Trushinski said there is progress being made to develop a long-term management plan for Medea Creek. He said it's important for the main stakeholders who have regulatory jurisdiction over the creek to work together with the community and he will report out on a meeting that is planned for August. J.L. Diaz mentioned that the recent fire safety presentations were very helpful and he feels like residents need to be sure to register for VC Alerts so they know what to do in real time during an incident.

- Laurie Getz Concerned about landscape problems in Oak Park.
- Denise Helvstein Concerned about generated traffic from the users of the Deerhill Park pickle ball courts.

8. Written Comments

Brian Mattson – Submitted comments on concerns about the poor quality of landscaping service being provided.

Mary Wiesbrock - Concerns about the City of Agoura disaster evacuation plans.

- 9. MAC Member Comments
 - JL Diaz mentioned he attended the concert in the park and that it was well attended. He encouraged community members to reach out to the Fire Safe Council for home assessments.
- 10.Rancho Simi Parks and Recreation District Representative Comments: District 5-Eric Lundstrom
 - Rancho Simi Recreation and Park District budget meeting will be held on Wednesday, August 6 at Oak Park High School (Room G-9).
 - The meeting will cover the overall budget, assessment revenues, and provide a financial summary.
 - District Appointments: Eric Lundstrom represents District 5, which includes Wood Ranch and Oak Park.

- There is currently a vacancy for District 3, following Josh Gray's resignation after moving out of the District.
- Four candidates have submitted applications to fill the position. The Board will
 review the applications and determine the appointment format, with a decision
 expected at their next meeting.
- Deerhill Pickleball Courts: The new pickleball courts at Deerhill were significantly more expensive than anticipated—twice the original estimate.
- Eric Lundstrom encouraged community members to be persistent in attending Board meetings and being the "the squeaky wheel" in advocating for needed maintenance improvements and projects in Oak Park.
- The Director has been working on a long-term permit to streamline improvements over the next four years.
- Environmental Projects:
- The Santa Monica Mountains Conservancy and CAL FIRE awarded \$3.3 million in grant funding for cleanup and restoration in the Medea Creek and Lindero Creek.
- Work will include removing dead vegetation, burnt materials, palm trees, and invasive plant species.
- The project will be publicly bid, and the Kanan Road to Oak Hills segment is already in that process.
- Currently, no funds are allocated to Simi Valley; Oak Park is being prioritized.
- Ongoing maintenance and community volunteer involvement will be critical to prevent future multimillion-dollar cleanups.
- Recreation Program & Events: The Fall Recreation Guide is being mailed beginning August 4 and includes new programs:
 - Archery (adults & youth)
 - Parent & Me music and movement
 - Wellness classes
 - Pickleball (a fast-growing sport)
- Music in the Park: July 12 featured Kenny Metcalf's Elton John tribute at Oak Canyon Park.
- Halloween Carnival: Scheduled for Friday, October 31 in Oak Park.
- July 31 is National Parks & Recreation Month. The District hosted events throughout July using the Mobile Rec Van with activities like youth archery and foam axe throwing to encourage families to get outside and enjoy the parks.
- Community Feedback & Discussion:
- Brianna Adams: Suggested revisiting the idea of adding a beach volleyball court at Deerhill Park (originally proposed two years ago but unfunded).
 Suggested improving the existing court at Indian Springs Park with new sand and better containment nets to prevent balls from going into the street— Yarrow YMCA's low nets were mentioned as a possible model. Eric noted

- that beach volleyball will soon be a high school sport and welcomed the suggestion.
- Residents are encouraged to email ideas or feedback to Eric Lundstrom and attend the next Rancho Simi Meeting—there are over 70 active projects, and time and funding are limited. <u>To send a comment to Mr. Lundstrom, please</u> click here.
- Comments from Michelle Santucci: Deerhill Park Pickleball Court Budget
 Overrun Initial budget was \$200k; final cost was \$400k. She requested a
 future discussion by the Rancho Simi Board on preventing similar overruns.
 Capital Improvements Emphasized the importance of including Indian
 Springs playground repairs in the upcoming Capital Improvement Plan budget
 due to safety concerns. Also flagged roof and flooring issues at the
 community center. Graffiti on Park Signage Praised Rancho for repainting a
 vandalized sign near Medea and Park View, which she reported before
 leaving on vacation.
- Brian Trushinski: Environmental Monitoring Urged the District to ensure that
 there is a full-time qualified professional environmental monitor onsite to
 supervise work crews during all three phases of the Medea Creek and
 Lindero Creek projects to ensure that sensitive plants and habitat are
 protected as well as prevent excessive vegetation removal in order to remove
 a palm tree, dead tree, or patch of invasive plant species. Project
 Communication Brian also asked that the District commit to providing clear
 public communication and signage when work occurs in the Creeks, including
 District staff contact info for the public to use should there be questions or
 concerns.
- Eric Lundstrom's Response: Acknowledged that the Board is concerned with cost escalation and is working to ensure that current estimates reflect inflation and rising material/labor costs.
- Michelle (follow-up): Requested broader community communication through all available channels, including Oak Park's Facebook, Instagram, and website.
- Tom Hansen: Reported that dog waste bag stations are now empty—
 previously always stocked. It appears someone took all the bags. The Park
 District has been contacted and is aware of the issue.

12. Announcements and Other Business

- Brianna Adams: Oak Park PTA hosting a community event on the Great Lawn at OPHS on October 4 from 3-6 all are welcome.
- Brian Trushinski: The MAC will be dark (no meeting) in August.
- District 2 Staff: Annual Oak Park Fire Station Open House: Date to be announced. Will hold end of September or October. Opportunity for community to learn more about home hardening and meet local first responders. Supervisor Gorell is also planning a Town Hall on Wildfire Zone 0 with the Fire Department on September 17 at Fire Headquarters at 5:30 pm.

13. Supervisor Gorell or a representative from his office for remarks

- Supervisor Gorell shared that he attended the Calleguas and Las Virgenes
 interconnection event. Was full circle for the Supervisor because 6 million dollars
 used for the infrastructure project came from Prop 1 which passed the legislature
 in 2014 when he was a State Assemblymember. He was the co-author of the
 legislation.
- He thanked the community, school district, park district and Public Works for staying late to provide updates/ask questions.
- He announced the hire of a new staff member. Crystal Stratton has been selected as the new District Field Representative. She comes from the County Fire Department where she managed public outreach. She will be assigned to assisting with the Oak Park MAC.
- He noted that he understands the community's concerns about landscaping and believes the gap in the contract impacted the maintenance. He shared that the Public Works team is committed to making improvements with the new landscaper.

- He acknowledged concerns about the Lindero Canyon Road/ Kanan Road shopping center and said that his team would connect with County code compliance and the property owner.
- He met with the Public Works Director and learned there were many factors impacting the timing of traffic lights on Kanan Road and the team is working to address and fix.
- He noted that he is on the Santa Monica Mountains Conservancy and Prop 4
 money is available for grants for wildfire prevention. Rancho Simi Recreation and
 ParkDistrict has received a grant through the Conservancy for Medea Creek.
- He was able to help secure \$1.2 million for things like brush clearance, use of goats, maintenance of fire roads, forward staging fire equipment, and financial support for Firewise councils. The funding went to Ventura County Fire.
