PUBLIC COMMENT

Public comments are an opportunity for members of the public to participate in meetings by addressing the Santa Rosa Valley Municipal Advisory Council in connection with one or more agenda or non-agenda items. Public comments by a member of the public at a single meeting are limited to a cumulative total of five minutes at such meeting unless the time allotment is increased or decreased by the Chair depending on the number of speakers. The public comment period during the opening part of the meeting to address non-agenda items is limited to 30 minutes total for all speakers; this 30-minute limit does not apply to items on the agenda.

To maintain a public meeting environment conducive and welcoming to receiving public comments from all members of the public, the audience is discouraged from engaging in displays of support or opposition to staff reports or public comments, including clapping, yelling, booing, hissing or cheering, that may create a disruptive environment for members of the public wishing to participate. Any person who disrupts or impedes the orderly conduct of a meeting will be instructed to cease the disruptive conduct. Failure to do so may result in that person being removed from the meeting.

Members of the public who would like to augment their comments with visual or audio presentations must submit their materials to the israel.rodriguez@ventura.org for review at least 48 hours before the meeting. The review will be conducted to determine only whether the materials are on matters within the jurisdiction of the Municipal Advisory Council, which would be disruptive of the meeting, or would foster illegality, such as

identity theft. If it is determined that materials are about matters not within the Municipal Advisory Council's jurisdiction, or would be disruptive of the meeting, or would foster illegality, use of County-provided equipment will not be allowed.

OPENING

- 1. Call to Order.
 - A. Chair Allison called the meeting to order at 6:08 p.m.
- 2. Roll Call.
 - A. Members Present: Michael Adams, Amy Elliot, Mark Burley, Debra Spafford, and Rosemary Allison were present. Quorum was met.
- 3. Pledge of Allegiance to the Flag of the United States of America.
 - A. Led by Zyg Martynowicz
- **4.** Approval of the Minutes of the meeting of the Santa Rosa Valley Municipal Advisory Council held on Thursday, May 15, 2025.
 - A. Mark Burley requested adjustments to the Minutes from 5/15/2025 to Item #9, Part 1. Motion, made by Mark Burley, seconded by Amy Elliot. The motion passed unanimously.
- 5. Agenda Review.
 - A. No changes to the agenda.
- 6. Approval of Consent Agenda Items A through C.

Motion to approve items A through C was made by Mark Burley, seconded by Amy Elliot. The motion passed unanimously.

- A. California Highway Patrol: Received and Filed
- B. Ventura County Fire Department: Received and Filed
- C. Ventura County Sheriff Department: Received and Filed
- 7. Public Comments Citizen presentations regarding Santa Rosa Valley Municipal Advisory Council related matters NOT appearing on this agenda. (See Guidelines above).
 - A. **Beaker:** Lived on Jennifer Way and had been talking to county agencies for months about a drainage channel that ran off of his property. Watershed Protection personnel had inspected but gave no solution. He was concerned because if the drain clogged on his property, it could cause problems for his neighbor onto whose property the drain ran.
 - B. **Lee:** Topic was on horse trail through Camelot. Lee was from the HOA at Camelot and had come to give input on the equestrian trail agenda item.

- **8.** Office of Ventura County Supervisor Jeff Gorell's Comments Brief announcements and report on County activities.
- 9. Council Comments Comments by Council members on matters they deem appropriate. A Council member may ask a question for clarification, make a brief announcement, or make a brief report on his or her own activities. A Council member may also provide a reference to staff or other resources for information, or request staff to report back to the body at a subsequent meeting concerning any matter. The Council may also direct staff to place a matter of business on a future agenda.
 - A. Rosemary Allison: Said that the fall harvest festival will be held on October 11th. She would love for people to sign up for the old-fashioned pie auction to either volunteer to run the booth or bake pies. Remarked that there had been a lot of chatter on the Santa Rosa Voice Facebook group regarding the equestrian trail developments with the Toll Brothers property. Allison asked for members of the public to give their input on CC&R rules. Noted that it was important for rules to stay public and be publicly accessible.
 - B. Mark Burley: Apart from Las Brisas, all HOAs had allowed bikes on trails and cyclists were mostly respectful and mindful of the horses, which the trail was intended for. E-bikes were beginning to change this nice conduct. COSCA trails allowed e-bikes, but trails had been seeing younger people being less respectful to people on the trail. The role of the easement was recreation for e-bikes, walking, and riding horses. Burley asked what was being done by the Ventura County Board of Supervisors in light of the recent immigration raids to protect farm workers.
 - C. **Israel Rodriguez:** Noted that the VC Sheriff did not collaborate with federal law enforcement, but it was still so soon since the Glasshouse ICE raids in June.
 - D. **Deputy Dino:** Stated there was no collaboration with ICE and VC Sheriff had no federal power. Only responded to incidents to keep peace.
 - E. Amy Elliot: Asked who responded to the Glasshouse Farms ICE raid.
 - F. **Deputy Dino:** Glasshouse Farms saw a response from VC Sheriff Camarillo Station as it was in their jurisdiction. Moorpark Station, which tended to Santa Rosa Valley, did not respond.
 - G. **Amy Elliot:** Noted that the Spook Canyon clearance had made for very nice hikes. Elliott noted that she had two Hispanic tenants who were both business executives and one of these tenants went to Pleasant Valley Hospital and was taken into custody by ICE even though the tenant was an American citizen. Stated that criminal foreigners must be deported, but the Hispanic community needed support.

- H. **Michael Adams:** Had removed tall weeds on his property and noted it was important to clear brush on property to harden against fire. Stated that rules for equestrian trails should be consistent across all HOAs.
- I. **Israel Rodriguez:** Introduced CHP Captain Zane of the CHP Conejo Grade Station. He was the new commander of the Conejo Grade Scales Station. He looked forward to helping out in the community and meeting new people.
- J. **Deputy Lemar:** Introduced the new Deputy Sheriff at Moorpark Station, Deputy Dina. Deputy Dina was training with Deputy Lemar and Dina read the crime report to the MAC and public.
- K. Council members then took some time to discuss recent home burglaries and how they could harden homes against burglaries.

- **10. Preparedness Community Presentation Office of Emergency Services & VCFD.** The purpose of this presentation is to provide an overview of the wildfire problem within the county, and the mitigations that can reduce the impact of fires in the County and Santa Rosa Valley.
- 11. Update on Toll Brother's Trail and Pending Connection to Santa Rosa Valley Trail System.
 - A. Field Representative Israel Rodriguez provided a PowerPoint from Ventura County Resource Management Agency indicating the equestrian easement located on the Toll Brother's development.
 - i. The presentation indicated the 16.5-foot-wide proposed easement for the trail.
 - ii. The proposed 16.5-foot-wide easement extends between the north property line of proposed lot 14 to the south property line of proposed lot 10. It was pointed out that the RMA map, slide 5 incorrectly showed the red line was drawn ending at lot 11 and not lot 10.
 - iii. According to the County Santa Rosa Valley Trail Master Plan, both equestrian easements will be publicly accessible.
 - iv. As part of the County Trail Master Plan, it indicates that the proposed Toll Brother's equestrian trail will connect to the Conejo Parks and Recreation District dedicated trail in the area.

- v. Also showed the 10-foot-wide existing easement for equestrian trail the runs on the northwest side of the development.
- vi. There were comments made by the Camelot HOA who opposed connecting the Toll Brother's Trail to the existing Santa Rosa Valley trail system for fear that it provides access to criminal activity for ingress and egress out of the community.
- vii. MAC member Mark Burley felt that it would help to have documentation from Toll Brother's indicating that they agreed the trail would provide public access.
- viii. It was noted that it would be difficult to connect the existing equestrian trail that runs along Santa Rosa Road and the northwest corner of the development to the proposed Toll Brother's 16.5-footwide equestrian easement because of the drainage ditch that is under watershed protection. It would require that a bridge be built over the ditch to connect the two trails.

12. Santa Rosa Valley MAC Committee & Liaison Reports:

Kevin Cannon gave an update on the progress of the SRV Firewise Ad-Hoc committee. The committee is making progress and there are approximately six communities that are signing up to become Firewise recognized communities.

- During the Labor Day Maximum Enforcement Period, the CHP made over 1,200 arrests for DUI, issued over 19,700 citations for speed violations, and conducted over 45,800 enforcement actions. 
- Fall in Ventura County often brings strong winds from the East, including warm Santa Anas. Such winds increase the fire risk. Hot, dry conditions with strong winds can trigger Red Flag warnings. Residents are encouraged to avoid activities that could spark wildfires, such as loose tow chains, driving into grassy areas with a hot muffler or carelessly discarding a cigarette.
- September is Fall Prevention Month. Falls are the leading cause of injury-related death for adults 65+ in the United States. In 2021 alone, they claimed more than 38,000 lives. Locally, 1 in 3 Ventura-County seniors will fall each year, and each hour another older Californian dies from a fall. The Ventura County Fire Department is supporting the county's Human Services Agency's Area Agency on Aging in hosting a fall prevention forum at VCFD headquarters Sept. 26. Registration is available online at VCFD.org.
- This year marks the 24th anniversary of the September 11 attacks on New York City and Washington, D.C. To honor the lives lost and the courage of those who responded, the Ventura County Fire Department invites the community to join firefighters in remembrance ceremonies across the county. Commemorations will take place at every fire station, department headquarters, and at Fire Dispatch. At 6:59 a.m. — the moment the first plane struck the Twin Towers — flags will be lowered to half-staff, and a moment of silence will be observed. VCFD dispatchers will share a broadcast honoring all who perished, followed by four sets of five bells, a traditional firefighter tribute. Firefighters may also read the names of the 343 FDNY members who gave their lives that day. Community members are welcome to reflect alongside firefighters, honoring not only the fallen first responders but also the law enforcement officers and civilians whose lives were cut short.
- Looking ahead, Oct. 5-11 will be Fire Prevention Week. This year's national focus is on lithium ion battery safety. Improper use, charging, storage or disposal can lead to intense fires that are difficult to put out. Some key tips: Take batteries off the charger once the charging cycle is complete. Recycle batteries (even the small ones) rather than throwing them in the trash. Inspect batteries if they fall or get dropped, and immediately recycle any that are damaged.

EVOLVING PUBLIC SAFETY POWER SHUTOFFS TO SUPPORT COMMUNITY SAFETY AND REDUCE THE RISK OF WILDFIRES



WHAT IS A PUBLIC SAFETY POWER SHUTOFF?

- A PSPS is when an electric utility temporarily shuts off power to reduce the risk of a fire caused by utility equipment. Dangerous fire weather conditions which include strong winds, dry vegetation and low humidity drive PSPS events.
- PSPS continues to be an important public safety tool during extreme weather conditions when the risk of wildfires is high.
- More than one-quarter of SCE's service area is in high fire risk areas. We're committed to keeping our communities safe as the threat of wildfires continues to grow.



NEW High Fire Risk Area (HFRA) CIRCUITS



SIGNIFICANTLY INCREASED OVER THE PAST 10 ACRES BURNED IN CALIFORNIA HAVE YEARS



MITIGATING WILDFIRES

- We're building upon the critical grid hardening investments we've made to date and continuing to adapt our mitigation strategies to face rapidly evolving risks.
- PSPS, when combined with our work on underground powerline systems, covered conductor, vegetation management and integrating advanced technologies for grid resilience, reduces the risk of wildfires caused by utility equipment and increase reliability during high winds and storms by limiting the exposure of electrical equipment to extreme weather.

MORGANSTEIN GRID HARDENING




Total Overhead: 22 miles

CC (Completed): 21 miles







Site Location







My wife (Simone Lagomarsino) and I are writing to ask if you could add the following comments onto the next Santa Rosa Valley MAC agenda package in relation to an open discussion item that affects us, as residents in the Santa Rosa Valley, regarding the planned equestrian trail in the Toll Brothers development on the Santa Rosa Road.

Here are our concerns and comments on this topic:

To the Members of the Santa Rosa Valley MAC:

As long-time residents of the Santa Rosa Valley, we are respectfully writing to express our deep concern in relation to the possible changes that are being discussed in the Toll Brothers' development on the Santa Rosa Road, which could eliminate the planned development of the equestrian trail in that new development. We have horses and have ridden extensively in the Santa Rosa Valley and its surrounding areas over almost 25 years. Please consider the following points from our perspective:

- We purchased our home in the Santa Rosa Valley in 2001, in part because of its longstanding commitment to equestrian activities and the extensive trail system that has been carefully developed and maintained over the years.
- We, along with so many other equestrian riders, feel truly fortunate to enjoy such a well-connected network of trails to encourage safe riding and have consistently supported efforts to extend, strengthen and maintain them.
- Furthermore, we have been enthusiastic supporters of the horse and walking trails, including the one on the northern side of our property, running parallel to the Arroyo Santa Rosa, which is an easement on property that we have maintained for almost 25 years.
- While we have heard that some households in the Camelot HOA are concerned about the
 presence of a horse trail adjacent to their homes, we have found equestrian riders and their
 horses to be very conscientious of our property. Over almost 25 years that we have owned our
 property, there has never been an incident on the horse trail on our property.
- As a result, we have been very supportive of extending the trails as outlined in the Santa Rosa Valley Trail Master Plan -- http://www.srvtrails.com/files/99001372.pdf
- From our understanding, the Master Plan was approved by the Board of Supervisors in 2014 and we understand that it is now part of the General Plan for Ventura County.

 Consequently, we understood previously that this planned development of the equestrian trail (creating an easement) on the Toll Brothers development has been a condition of this property's development for decades.

 It will make a safer connection for horses going from the Arroyo Santa Rosa trail to the Lower Santa Rosa (aka Baseline) trail and Box Canyon; conversely, the elimination of this trail will

increase the risk for horses and their riders.

 In conclusion, we are strong supporters of the creation of this connecting trail "across" the Toll Brothers' development, which development is on the Santa Rosa Road.

We would appreciate the earnest review of our concerns by the members of the MAC. We are available to discuss this with any member of the MAC. We encourage the support for this trail by all members of the MAC.
